OFFICE ORDER

The Director, ICAR-Central Institute of Fisheries Education (ICAR-CIFE), Mumbai, is pleased to inform that Nanavati Max Super Speciality Hospital, Vile Parle (West), Mumbai, has been empanelled with ICAR-CIFE, Mumbai for providing medical facilities to the employees, their dependent family members, and pensioners/family pensioners of ICAR-CIFE, Mumbai on a cash payment basis.

Nanavati Max Super Speciality Hospital has agreed to extend all available OPD consultations, diagnostic investigations/procedures, and IPD treatment facilities at the prevailing CGHS rates. Since the empanelment is strictly on a cash payment basis, the beneficiaries of ICAR-CIFE shall make the payment directly to the hospital at the time of availing OPD/diagnostic/IPD services or at the time of discharge, as applicable. The beneficiaries may subsequently claim reimbursement of the admissible medical expenses from the Institute in accordance with the applicable rules and guidelines.

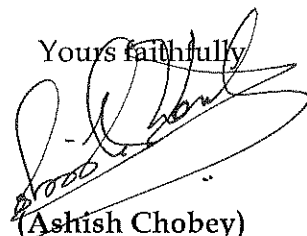
The hospital shall issue detailed and itemized bills, along with the necessary break-up of charges and discharge summaries, in a format suitable for processing institutional medical reimbursement claims. Employees, pensioners, and family pensioners shall submit their reimbursement claims directly to the Institute as per the prescribed procedure.

To avail medical services at CGHS rates, beneficiaries shall be required to produce their original ICAR-CIFE Identity Card at the time of registration. Dependent family members shall be required to produce an authorization letter issued by the concerned ICAR-CIFE employee, along with any other documents, if required.

The empanelment/Memorandum of Understanding (MoU) shall remain valid for a period of three (03) years, with effect from 25 July 2026 to 24 July 2029, unless terminated earlier in accordance with the terms and conditions of the MoU.
