Training cum demonstration proposal under NEH -2025-26 at Manipur

98/ **Proposal: 03 days Hands on training on "Modern methods of freshwater aquaculture for improvement of livelihood" at Imphal West, Manipur under NEH scheme- Reg. (Tentative date- 04/11/25 December, 2025)**

AR-CIFE, Kolkata

This project is proposed for upliftment of small and marginal farmers of Manipur which is an organic state. Fish culture in Manipur is a significant socioeconomic activity, encompassing traditional practices like rice-fish farming and modern techniques in ponds and integrated systems. While there is a growing adoption of scientific methods for species like rohu, silver carp, and grass carp, challenges include a lack of training and high-quality inputs, the risk of invasive species harming native fish, and issues with diseases. Due to a lack of technical knowledge about scientific methods of fish culture, aquaculture production is less. But it has a great potential for fishery and aquaculture due to plenty availability of freshwater resources. Therefore, it is proposed to conduct a three days training cum demonstration programme on "Modern methods of freshwater aquaculture" for 25 fish farmers of Imphal West, Manipur with initial aquaculture inputs like seed, feed etc. The program will be conducted in collaboration with ICAR Complex for North Eastern Region (ICAR-NEH) Manipur Centre.
