## **General Instructions for the candidates:**

- 1. Interested candidates fulfilling the above qualifications are invited to appear for Walk-in-interview at ICAR-Central Institute of Fisheries Education, Panch Marg, Versova, Mumbai 400 061 along with filled in application form (as per the format annexed), all the original certificates from Matriculation onwards must be produced at the time of interview in either original or provisional, Bio-Data, attested copies of all experience certificates, testimonials etc., one passport size photograph and one set of the self-attested photocopies of all the required certificates from matriculation and onwards and an attested copy of recent passport size photograph pasted onto the application form.
- 2. The Initial Appointment will be for one year, which shall be extended further based on the satisfactory performance of the candidate. In any case, the total duration of the appointment will not be more than 3 years.
- 3. Concealing of facts or canvassing in any form shall lead to disqualification or termination.
- 4. Candidates are required to produce original certificates at the time of interview, which will be returned to them.
- 5. The selected candidates shall not claim any regular appointment as the position/s is/are purely temporary.
- 6. No TA/DA will be paid for appearing in the interview.
- 7. Only those candidates will be allowed to appear who have all the original certificates and their photocopies. Candidates who have final mark sheets but do not have their provisional

- or original certificates for the Graduate degree. or Master's degree (as the case may be) with them, will NOT be allowed to appear for the Interview.
- 8. The candidates are required to submit the application form at the time of interview as per the format annexed along with the declaration.
- The candidate intending to visit for an interview, if any of his near or distant relatives is an employee of the ICAR/CIFE, has to declare his/her name, designation, nature of duties, and relationship in writing as detailed in ANNEXURE-III, before the start of the interview.
