CIRCULAR

As a part of preventive measures against the spread of COVID-19, the following precautionary measures are to be taken in the CIFE premises: $\frac{1}{2}$

- It is mandatory for all Staff & Students to strictly follow COVID-19 preventive protocol (i.e. wearing mask properly, using sanitizer frequently and maintaining social distance) and to be careful all the time: especially, for the students whether in class rooms, laboratories, canteen, hostel, mess and while moving in the campus.
- 2. All the Students advised to remain in the campus only and not to venture out of the campus unless there is a medical emergency or extremely unavoidable situation.
- 3. Theory classes is to be taken using online modes to the extent possible.
- 4. As high transmission rate of present pandemic situation, to stop all home-delivery services viz., courier, grocery, vegetables etc. from the time being. However, these service providers can deliver the items at main gate and individuals can collect the same. Essential and emergency services like medicines, gas, repairs of electronic goods, etc. may be allowed after ensuring that they are healthy and fully vaccinated
- 5. All staff and students are advised to get their 2 doses vaccination done on priority.
- 6. The AAO (Sores & Purchase) may procure essential items/ gadgets like Sanitizers, liquid disinfectants, disinfectant sprays, spray pumps, gloves, masks, PPE kits, etc. in sufficient numbers to tackle any emergency situations.
- 7. The movement of outsiders/ guests in the campus is restricted and the International Guest House facility is shut down for a few months till the pandemic situation calms.
- 8. The staff & students should strictly adhere to Advisory/ Guidelines on COVID appropriate behavior issued by MCGM/ Govt. of Maharashtra from time to time.
