**Sub : Contractual engagement for the post of Chief Engineer Grade – I onboard MFV Saraswati.**

Sir,

The Director, Central Institute of Fisheries Education (CIFE), Mumbai is pleased to accept his application for contractual engagement for the post of Chief Engineer Grade – I on contract in the Institute purely on bilateral contract basis for consolidated amount of Rs. 58,682/- (Rupees Fifty Eight Thousand Six Hundred Eighty Two only) per month (for 26 working days) in addition to messing allowance of the applicable rates or timely revision made by Fishery Survey of India (FSI) or Authorized Govt. Agency whichever is less on the following terms and conditions:-

1. The contract will come into force with effect from the date of execution of agreement and will remain in force for a period of One Year. He should submit copy of original certificate of competency.
2. An amount of one month's package/ contract amount should be deposited by He towards Security Deposit in the form of crossed Demand Draft drawn in favour of "ICAR Unit - CIFE" Payable at Mumbai. The Security Deposit shall be released within 30 days after the expiry of the contract.
3. The Chief Engineer duties are to be carried out full time on vessel MFV Saraswati.
4. The Chief Engineer duties should be carried out under the direct supervision of the concerned Scientist-in-Charge (Vessel Management).
5. He will not allow availing any other wages during the contract period. Therefore, nothing extra shall be paid over and above an amount of Rs. 2,257/- (Rupees Two Thousand Two Hundred Fifty Seven only) per day.
6. Income tax and any other mandatory taxes will be deducted from the bill as per statutory provisions.
7. He shall be fully responsible for all legal and statutory matters arising out of the contract.
8. The contract shall be terminated in case of unsatisfactorily services.



9. He will not be entitled for any Dearness Allowance, CCA, Bonus and LTC during your contract period.
10. He will not be entitled for any pension or retirement benefits after completion of your contract period.
11. An amount equivalent to two days of the contract amount, subject to a minimum of Rs. 500/- (Rupees Five hundred only) will be levied as liquidated damages per day. Whenever and wherever if it is found that the work/ service is not up to the mark satisfactory.
12. The Director, Central Institute of Fisheries Education, Mumbai reserves the right to terminate the contract at any time by giving one month's notice. The decision of Director, CIFE, Mumbai shall be final and binding on He.
13. The agreement/ contract period shall stand terminated automatically on expiry of stipulated period if not extended prior to stipulate date. He will not be entitled for any claim for services rendered after expiry of stipulated date of contract.
14. This letter will constitute a legal and binding contract between Central Institute of Fisheries Education (CIFE) and He till such time the contract agreement is signed. He will enter into and execute the contract agreement within 15 days from the date of issue of this letter. He are requested to arrange the non-judicial stamp paper of value of Rs. 100/- for signing the contract agreement. A copy of agreement if enclosed herewith for further necessary action.

The duplicate copy of this letter may please be returned duly accepted and signed by He in token of Her acceptance to this Letter of Intent within 7 days from the receipt of this letter, failing which it will presumed that He are not interested in the work.
