The Gender Champion will receive a **certificate of appreciation** from the Head of the Institution for his/her committed efforts on successful completion of activities towards promoting gender equality. Any candidate, who fails to attend two meetings will be terminated from the Gender Champion Club.

Roles and responsibilities of the Gender Champions are appended below. Gender Champions have to plan and execute their activities with the consultation of Nodal officer. periodic progress of the activities will be evaluated by one committee constituted by competent authority.

Roles and Responsibilities of a Gender Champion

The responsibilities of the Gender Champion will include the following:-

1. To motivate and engage students in gender mainstreaming activities at the Institution in the form of **focused group discussions, debates, poster competitions** etc.
2. To promote the equal participation of students in campus activities.
3. To **identify gaps** in campus activities vis-à-vis gender, and interact with the authorities for addressing these gaps, e.g. observe classrooms to detect bias in interactions.

4. To promote Gender Champion Club in institution and undertake innovative activities, like creating a website or blog on gender equity and regularly writing an equity column on issues on, e.g. **untold stories of extraordinary men and women** who changed our lives, **organize film screening on gender equity** etc.
5. To organize awareness programmes on various gender issues including legislations to influence behavior change. This could be facilitated through **workshops, theme based plays, films, painting competition**, etc.
6. To organize **exposure visits** to various public service institutions at (public health centres, hospitals, post offices, banks, police stations, SDM/DM office to facilitate knowledge about gender issues as they affect diverse populations.
7. **To popularize phone numbers** of such services as police helpline, women helpline, hospitals among students.
8. To arrange for providing necessary life skill education and information/guidance about existing public services to their fellow students.
9. To demonstrate knowledge of important Government schemes, events, legislation, and court rulings which has a major impact on the treatment and experiences of diverse groups.
