It is to emphasize that, awards will be considered for 2017 and relevant period of reporting and consideration would be strictly followed from 01.04.2016 to 31.3.2017 for 2017, for the award listed in the table, on the basis of publication and degree/ thesis awarded between the above mentioned period.

Award Endowment Fund will contribute towards the travelling expenses of student selected for the award at a rate corresponding to the amount of 2nd Class Mail railway fare by the shortest route to the place from the Railway Station nearest to the normal place of residence of the student or from where he/she actually performs the journey, whichever, is nearer to the CIFE, Mumbai, and back to the same station or the amount of Railway fare actually incurred by the student whichever is less provided he/she fulfill all the conditions.
