Online Certificate Course

Description of the job:

- The Service provider has to provide web-based micro-learning platform to host the online certificate course.
- ICAR-CIFE will provide learning programs material each comprising up to 10-12 content sources (Modules) with up to 20 multiple choice questions per module.
- Each Module shall be provided as insert format, video and/or as a PDF file with up to three language-translated versions in addition to the original native version.
- Content management system should be designed to offer ICAR-CIFE the widest possible choice for content creation, publication, storage and updating content;
- The services can be accessed via any Internet-enabled device for the advantages of geographically dispersed and diverse population of ICAR-CIFE stakeholders worldwide and their widespread adoption of mobile devices;
- The party/firm has to provide facility for automatic registration of student/trainees upon feeding the relevant information by the candidate upon payment of requisite fee for the course.
- The firm has to provide linkage to ICAR-CIFE, Mumbai website for online publishing of the programme.
- The party/firm will allocate sufficient time and resources to effectively:
 - Register candidates upon payment of fee (to be decided by CIFE, Mumbai) for the course and award certificate automatically after completion and passing of all the modules successfully.
 - Upload course material and content including associated multiple choice questions for the conduct of knowledge test of the candidate.
 - Provide technical support to ICAR-CIFE staff and users.
 - Manage the project and related consulting services up to 3 years
 - Provide onsite project management for the entire operation period of 3 years whenever required.
 - The party/firm has to acknowledge the ICAR- CIFE's exclusive ownership of all courseware provided for the purpose.
 - The payment to the party/firm will be made in four installments. The first 60% will be paid after development and successful online screening on website of ICAR-CIFE as well as service provider. 2nd and 3rd installment of 10% will be paid after successful running of the program for first and second year, respectively. The final installment of 20% will be paid after satisfactory running of program at the end of third year.
