1	Standalone (Display & Analysis), lightweight, bench top, automated cell counter with small footprint. Optional mouse can be connected if required.				
2	Should contain brightfield and florescence.				
3	Should contain atleast 5 megapixels magnification. Autofocus with manual focus option.				
4	Should be able to count objects in a range of ~5–50-micron size & concentrations of 1 x 10E4 – 1 x 10E7cells/ml. Must have pre dilution calculator.				
5	Required sample volume should not be more than 10µl.				
6	The counting algorithms should be able to identify clear delineations of cell boundaries within clumps of cells. Cell count should be based on size and circularity.				
7	Processing time between sample to results (total count with Live & Dead %) should be around 10-20 seconds.				
8	USB port to export Excel sheet data, JPG/TIFF Image, FCS File & PDF report. There should be an option for wifi connectivity using dongle.
