CIFE is not responsible for any postal delay, in case the tenders are sent by post.

4. Details of Vehicles owned by your firm.

Following are the Terms and Conditions:

1. Tenders submitted without above mentioned documents will be rejected out rightly.
2. Tender validity is only for 90 days.
3. Quoted rates should be valid for 1 year i.e. the period of the AMC extendable up to 6 months whenever applicable/ necessary.
4. Taxes, if any, as applicable, should be clearly mentioned; failing which, it will be presumed that the quoted rates are inclusive of all taxes.
5. Vehicles supplied should be as per the instruction mentioned in the enclosed annexure.
6. No advance shall be paid.
7. Non-transferable tender document containing details of the terms and conditions of the contract, etc., can be obtained from the office of the Assistant Administrative Officer (P), Central Institute of Fisheries Education (CIFE), Mumbai-400061 on payment of Rs. 1000/- (Rupees One Thousand only) in cash payable or through swipe card at CIFE's cash counter on all working days during Office hours (1100 hrs. to 1600 hrs.)

8. The tender document can also be downloaded from CIFE's web site www.cife.edu.in. The tenderers who download the tender document from CIFE website must enclose a Demand Draft for Rs.1000/- drawn in favour of "**ICAR Unit – CIFE**" payable at Mumbai towards the cost of the tender document. The tenders submitted without the Demand Draft for Rs. 1000/- towards the cost of tender form shall be rejected.
9. The total amount of Earnest Money Deposit (EMD) payable is **Rs. 10,000/= (Rupees Ten Thousand only)** in the form of Demand Draft (DD) for the fulfillment of contract. DD should be drawn in the name of "**ICAR Unit – CIFE**" payable at Mumbai.
10. Payment will be made only after the Vehicle hiring in full quantity and as per prescribed technical specifications.

12. Successful Tenderer shall not transfer contract to any other contractor
13. Payment shall be made by RTGS only.
14. No part payment shall be made.
