Sealed Tenders are invited for construction of three numbers of tube-wells of the following specifications.

Specifications:

Tube well of 10" diameter, depth of around 50-100 feet with bore pipe of PVC (ISI pipe of 6 Kg pressure) with delivery pipe of 3" diameter fitted with electrical submersible pump of 7.5 HP (ISI, V-6, 4 stage pump). Complete labour work with fitting of final bore pipe, installation of pump and outer fittings, cleaning of bore will be done by the tenderer with his own machine. All material like PVC pipe to be installed, pumping set and other related fitting including electrical fitting (electrical panel, main switch, electrical cable etc) will have to be provided by the tenderer. Therefore, the proposal submitted should be inclusive of all costs and taxes.

- 3. Quotations received after due date and time shall not be entertained. The quoted rates must be valid for one year.
- 4. Contractor/ agency should be experienced in above said work.
- The quotation should be accompanied by an Earnest Money Deposit (EMD) amounting to Rs.6000/-(Rupees Six Thousand Only) in the form of crossed demand draft drawn in favour of "CIFE, Rohtak Center".
- 6. The EMD of successful bidder shall be converted into a part of security deposit. The EMD of unsuccessful bidders will be returned within 15 days from the date of award of work to successful bidder.
- 7. The successful bidder has to pay Security Deposit amounting to 10% of the quoted amount. The security deposit will be released only after six months from the date of successful completion of work.
- 8. The defect liability period is 6 months. Any defect arising in the defect liability period is to be rectified by the contractor without any extra cost, failing which the same shall be done departmentally at the **"risk and cost"** of the contractor and the amount of expenditure shall be deducted from the security deposit.
- 9. The quoted rates should be inclusive of cost of material, carriages, all taxes whatsoever, storage, watch and ward, wastages, etc. The quoted rates shall not be increased under any circumstances.
- 10. Income tax will be deducted at source from the bill as per rules.
- 11. The Institute will not supply any tools, equipments, materials. The contractor has to make their own arrangement.
- 12. The EMD submitted by the bidder is liable to be forfeited by the Institute, if the selected firm/bidder fail to commence the work within seven days from the date of receipt of work order.
- 13. The work must be completed within the specified time period, failing which a penalty up to 5% of the tendered amount per month will be charged.
- 14. Works are to be executed strictly as per the specifications mentioned in the tender document failing which work shall be rejected.
- 15. The material used for renovation must be approved by the officer In-charge (Works)/ site in-charge before using failing which works shall be rejected.
- 16. The agency has to abide by all rules and regulations pertaining to labour act. The contractor has to take all necessary steps for the welfare measures of labours employed by him at the site.
- 17. The agency will be fully responsible for providing medical facilities to their labourers in case of any accident, etc. Matters related to labour welfare/problems should be dealt by the contractor only. CIFE, Mumbai shall not be responsible in such matters.
- 18. Taxes, if any, should be clearly mentioned in the quotation, failing which it will be presumed that the quoted rates are inclusive of all taxes. No additional tax will be allowed if the same is not mentioned in the quotation document.
- 19. The tenders/bidders in their own interest are instructed to visit the site for understanding the site conditions, nature of work, etc.
