The firm should submit sealed quotation address to the Officer in Charge, ICAR-Central Institute of Fisheries Education, Kolkata Centre 32, GN, Block, Sector –V, Salt Lake City, Kolkata-91 <u>preferably by Register/Speed post / by hand (in the quotation box fixed at office room No.9).</u>

The firm is requested to submit photocopies of valid documents namely trade license, company registration certificate, PAN card G.S.T Number & Rate along-with quotation and these are subjected to verification with original at the time of placement of work order, if needed. The envelope containing quotation must be super scribed with "Annual Maintenance Contact for Pest Control" in the bold letter with File No. & date. The firm should quote lumsum amount per year including all taxes and should be.

It is mandatory that firm has to deposit security money @ 10% of the quoted amount valid for at least 6 months for processing of the quotations. In a form of bank demand draft drawn in favour of "ICAR (CIFE) Subunit, Kolkata"/ Before undertaking job in case of selection.

The Officer-in-Charge, CIFE, Kolkata reserves the right to cancel quotation without assigning any reason, if the firm fails to comply the terms & conditions laid herein.

General terms & conditions

- 1. The firm must inspect the site before submitting the quotation.
- The firm should maintain a log book of all complain and obtain satisfactory report from the officer concerned.
- 3. The firm shall engage all the men tools and plants conveyance for transporting required for the work
- 4. The firm shall take into account basic price, cost of labour and taxes as applicable, conveyance before quoting the rates. No extra claim what so ever in this regard shall be entertained.

- 5. Security deposit of the above work will be retained by the office and the same will be refunded after successful completion of the period of AMC as specified.
- 6. CIFE reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.
- In case of unsatisfactory service, ICAR-CIFE reserves the right to terminate the contract by giving 15 days' notice and forfeit the security deposit.
- 8. The payment shall be released on monthly basis on successful competition of the work, against the bill provided by the party on due certification of satisfactory services by Section-in-Charge. Statutory taxes like income tax, work contract tax/service tax etc. as applicable shall be deducted from the payment.
- The successful firm shall not engage any sub-Contractor or transfer the contract to any other person/firm/agency in any manner
- 10. It is the responsibility of the contractor to maintain cleanliness and good hygienic conditions in the campus in respect of pest control contract.
- 11. Any injury/accident/death to the worker during the contract period shall be the total responsibility of the contractor, and the compensation, etc. Payable under the labour laws shall be paid by the contractor.

SCOPE OF WORK

Under this contract the following services are to be provided.

- 1. Rodent Management Services: This services will carried out for controlling rat problem using Government approved chemicals inside as well as outside the premises and safeguarding the important files, papers, Boxes, carpets, electrical and Telephone wiring, etc. from rodents damage. This service will be provided in the entire office area i.e. (office, laboratories, hostels, guest houses and residential quarters) inside the building area including office rooms, toilets, corridors, etc. and outside the building premises. The treatment should be carried out by mechanical trapping on each floor and service operator will keep on changing their location/position during his visit at ICAR-CIFE, using glue-boards and poison baiting in outside area only. For providing the services, the services operator of the contractor shall visit ICAR-ICAR-CIFE, Kolkata Centre for controlling the rodent problem. The special chemical/ pesticides required for pest control services, if any, during the course of contract, should be arranged by the firm.
- 2. Bed-Bug Treatment: In the Hostels & Guest Houses and office etc; quarterly treatment using Government approved chemicals as per the standard approved procedure, for one full year
- **3. Anti-termite treatment:** For all the buildings located in the ICAR-CIFE, Kolkata; quarterly treatment using Government approved chemicals as per the standard procedure for one full year.
- **4. Cockroaches Treatment:** For all the buildings located in the CIFE campus; quarterly treatment as per the following terms & procedure. Approved procedure and **Government approved Gel or spray** with complete warranty for Cockroaches Treatment for one full year.
