## OFFICE ORDER

The Director, Central Institute of Fisheries Education, Mumbai is pleased to allot Quarter No. 01 in the Type I Quarters, Godavari Building at CIFE Old Campus to Mr. Akhtar Fakir Miya Mullaji, Skilled Support Staff, ICAR – CIFE, Mumbai on the following terms & conditions mentioned here under:

- 1. That the license fee shall be recoverable from her under F.R. 45-A with effect from the actual date of occupation of the quarter.
- 2. That he should furnish a declaration in the prescribed form that he owns/ does not own a house in the District of Mumbai either in his name or any of his dependent family members.
- 3. In case of refusal or non-occupation of the above allotted residence within the stipulated period, he shall not be eligible for another allotment for the remaining period of the current allotment year.
- 4. The recovery of license fee shall be made as per revised rates issued by the Govt. of India, Ministry of Urban Development & Poverty Alleviation, Directorate of Estates, New Delhi vide Office Memorandum No. 18011/1/2009-Pol III dated 28.04.2011 and No. 02(06)/2013 E& M dated 10.12.2013 from the date of occupation of the said quarter. He is not eligible for the payment of HRA.
- 5. He should also abide by all relevant rules and orders as modified from time to time by the CIFE/ ICAR.
- 6. In the event of any situation required in the interest of the institute, Director, ICAR CIFE may direct the incumbent to vacate the allotted accommodation.
- 7. As per CIFE Allotted Rule-3, Officer owning houses at or near stations of their posting shall be eligible for allotment of residence under these rules in order of their date of priority. The matter relating to the recovery of the License Fee from house owning officers shall be determined in accordance with the orders issued by the Govt. of India in this behalf.
- 8. That the allotment of the Quarter No. 01, Type I Quarters, Godavari Building, ICAR CIFE, Old Campus will stand cancelled, if its possession is not taken by him within the stipulated period of 8 days from the date of issue of this Office Order and he shall not be eligible for another allotment for a period of one year from the date of allotment letter.

This supersedes the earlier office order of even number dated 30.03.2023.
