OFFICE ORDER

With the approval of the Competent Authority, and based on the recommendations of the Three-Member Scrutiny Committee constituted for scrutiny of applications received in response to **Notice Inviting Applications No. 32(33)/2025-26/Works dated 02.06.2026**, the following **35 (Thirty-Five)** firms, as detailed in **Annexure-I**, are hereby empanelled for execution of minor Civil and Electrical works at ICAR-Central Institute of Fisheries Education (ICAR-CIFE), Mumbai.

The empanelment shall be governed by the following terms and conditions:

1. The empanelment shall remain valid for an initial period of **12 (Twelve) months** from the date of issue of this Office Order and may be extended further, up to a maximum period of **03 (Three) years**, subject to satisfactory performance and approval of the Competent Authority.
2. Empanelment shall **not confer any right or guarantee** for award of work. Works shall be allotted as and when required, based on administrative requirements, availability of funds, and in accordance with the applicable rules, procedures, and terms and conditions of the empanelment.
3. ICAR-CIFE reserves the right to remove any firm from the panel or cancel the empanelment at any time in case of unsatisfactory performance, submission of false information, breach of contractual obligations, or any other valid administrative reason.
4. The empanelled firms shall strictly abide by all the terms and conditions stipulated in the Notice Inviting Applications. The said terms and conditions shall form an integral part of this empanelment and shall be binding on all empanelled firms. Any violation or non-compliance thereof shall render the firm liable for appropriate action, including removal from the panel, as deemed fit by the Competent Authority.
