TERMS & CONDITIONS OF QUOTATIONS:

- 1. The prices shall be quoted in Indian Rupees only. Each bidder shall submit only one quotation.
- 2. All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- 3. No advance payment or any part payment will be made. The payment is normally made within 15 days from the date of receipt of item / material in good condition as per order.
- 4. The successful firm must mention Bank Account number along-with the name of bank and its IFSC code in the bill at the time of supply of ordered items. The payment will be made through RTGS/ Bank Transfer only.
- 5. Quotation not found according to specifications will not be considered. The manufacturer / Dealer should quote only one type of fish feed and seed meeting our specification. The firm should also submit their quotation supported by relevant printed literature.
