Terms & Conditions

1:- **Eligibility Criteria**: Agencies experienced in auctioning woks in government, semi government & private organizations.

2:-Submission of offer: Agency shall quote their offer in separate sealed envelope super scribed as **Auction of Vehicle-**

a:- A copy of tender document having every page sealed & signed by the authorized representative / tender indicating of tender document.

b:- Documentary evidence in respect of the Eligibility Criteria mentioned in Para No.1 above.

C:- EMD charges 2% of total amount of bid in the form of DD in favour of ICAR CIFE Sub Unit Kolkata .

D:- Applicable (18%) GST to be paid by the party.

A sealed envelope separately for each vehicle, containing above shall be addressed to the OIC, ICAR –Central institute of Fisheries Education, 32 GN Block Sector –V, Salt Lake Kolkata- 700091

The tender will be considered whose Bidis found to be qualified and acceptable to CIFE.

3:- Earnest Money Deposit (EMD): Interested party should deposit an EMD 2% quoted value in favour of ICAR CIFE Sub Unit Kolkata. Tenders received without EMD/inadequate EMD, shall be summarily rejected.EMD of unsuccessful bidders shall be returned after acceptance of work order by successful bidder & EMD of successful bidders shall be released after acceptance of work order by successful bidder & EMD of successful bidder shall be released after removal of mentioned items from site and handing over the chassis number and number plate cutting of the vehicle to officer in –charge, ICAR-CIFE, Kolkata. No interest is payable on EMD. The EMD may be forfeited under the following circumstances:-

a:- If a bidder withdraws his bid during the period of bid validity specified in Tender.

b:- If the agency fails to expenditure to execute the contract.

4:-Experience: similar works include auctioning works in government, semi government & private organizations .documentary evidence in support shall be submitted with the bid.

5:- Validity period of Bid: Bid shall remain valid for 90 days after the date of bid opening. The bid valid for a shorter period shall be rejected. A bidder accepting the request and granting extension will not be permitted to modify his bid.

6:-Deadline for Submission of Bid: Bid must be received by ICAR-CIFE at the address specified and not later than the date and time specified in the Tender.

7:-Late Bid:- Any bid received late after the deadline for submission of the bid shall be rejected and returned un-opened to the bidder.

8:- Opening of Bid:-ICAR-CIFE shall open the bids in presence of authorized bidder's representative who will be present at time of opening tenders. A maximum of two representatives of any bidder shall be permitted and authorized to attend the bid.

9:- Payment terms:- The entire amount of quoted price shall be submitted to ICAR-CIFE in the form of DD within 2 days from receipt of Office order.

10:- other terms &conditions:-

a:- Successful bidder implies the party/agency who bid the highest amount in the above mentioned auction for each vehicle separately.

b:- Rule shall be quoted in whole Rupees. The tax as applicable under govt. norms shall be informed later for preparation of exact DD amount.

C:-The mentioned items are sold on **AS is where is basis** and the buyer shall have to ascertain and get satisfied with conditions of vehicle before tendering/participation in bidding and no complaints what so ever about the conditions etc.of the same will be entertained by CIFE later.

d:- The interested bidders may inspect the vehicle at site on any working day between 11:00 am to 04:00 p.m.

e:- Tender will be submitted in the office of undersigned up to 11.00 p.m. on 31.07.2023.

f:-The successful bidder has to accept the office order within two(2) working days of its issue.

g:- The time period for taking out vehicles from the campus of ICAR-CIFE is 2 days. The EMD shall be returned only after taking out the vehicle from CIFE campus.

h;- The bidder shall ensure all standard safety norms are followed while doing works.The buyer will employ his own labour and means at his own cost and risk for taking out the vehicle.

i:-In case of failure of party to execute /to comply with the order as per the terms and conditions of the order within 5 days, the Earnest Money Deposit (EMD) will be forfeited.

J:-If the first successful bidder after receiving the office order fails to take out the auctioned vehicles within a period of 5 days, the order shall be treated as cancelled and his EMD will be forfeited. The fresh order will be issued to 2nd highest bidder. If the second bidder also fails to take out the auctioned, the EMD shall be forfeited and fresh order will be issued to next highest bidder. This process shall be continued as per the set procedures of the institute. The decision of Officer in Charge, ICAR-CIFE Kolkata shall be final and binding on concerned in such matters.

K;-Arbitration: Any dispute in relation to or arising out of this shall be resolved amicably by the parties. Unresolved disputes shall be referred to Arbitration. The Arbitrator shall be appointed by the OIC, ICAR-CIFE, Kolkata. The venue of Arbitration shall be Kolkata. Laws of India shall be the governing laws.

I;- CIFE reserves the right to postpone /withdraw/cancel the tender without assigning any reasons. No correspondence shall be entertained in this regard.
